### 25-212 2026 Operating Budget - Submission

Moe Hosseini-Ara, City Librarian, Marco Cuoco, Director, Finance & Chief Financial Officer, and Alice Yu, Senior Manager, Budget & Financial Reporting presented highlights of the operating budget to the Board.

**Moved by** Jonathan Hoss, **seconded by** Soo Wong: **That** the Toronto Public Library Board:

- approves the 2026 operating budget submission of \$280.790 million net (\$301.919 million gross), which represents a \$26.246 million net (\$28.618 million gross), or 10.3%, increase over the 2025 operating budget as detailed in Attachment 1, and is comprised of:
  - a. a base budget of \$280.225 million net (\$299.680 million gross), which represents an increase of \$25.681 million net (\$26.379 million gross), or 10.1%, and is comprised of:
    - i. annualization of prior year approvals of \$11.075 million net (\$10.262 million gross), or 4.4%
    - ii. base budget changes for incremental staffing and benefit costs of \$10.938 million net and gross, or 4.3%; and
    - iii. other base budget changes of \$3.667 million net (\$5.178 million gross), or 1.4%.
  - b. service enhancement requests totalling \$0.565 million net (\$2.239 million gross), or 0.2%.

#### **25-213 2026-2035 Capital Budget – Submission**

Moe Hosseini-Ara, City Librarian, Marco Cuoco, Director, Finance & Chief Financial Officer, and Alice Yu, Senior Manager, Budget & Financial Reporting presented highlights of the 2026-2035 capital budget to the Board.

**Moved by** Deputy Mayor Paul Ainslie, **seconded by** Sakariya Ahmed: **That** the Toronto Public Library Board:

- 1. approves the 2026-2035 Capital Budget and Plan submission of \$102.129 million gross (\$53.666 million debt) for 2026 (including \$1.732 million of 2025 carry forward) and \$697.695 million gross (\$488.075 million debt) over 2026-2035, comprised of 19 projects as detailed in Attachment 1;
- 2. approves the TPL Capital Delivery Constraints, or unfunded project list, totalling \$0 gross and debt in 2026 and \$343.929 million gross (\$162.734 million debt) over 2026-2035, comprised of nine project as detailed in Attachment 2;
- *authorizes staff to forward this capital budget submission to the City for consideration.*

     Housing Co-operative on terms satisfactory to Corporate
     Real Estate Management in consultation with the Housing
     Secretariat and the City Librarian;

- b. City Council approves the transfer of the property at 40 Orchard View Boulevard to the City of Toronto;
- c. Toronto Public Library Board's authority and interests continue to be respected throughout the process; and
- **2.** authorizes the City Librarian to act on its behalf to execute the title transfer, any other ancillary documents and enter into any required agreements.

    - iii. November 1, 2032, to October 31, 2033, for \$407,147
    - iv. November 1, 2033, to October 31, 2034, for \$419, 361
    - v. November 1, 2034, to October 31, 2035, for \$431,942
